Fakafetongi Pa'anga Muli Ta'efakalao

'Oku fakatokanga'i 'e he Pangikē Pule' 'oku 'i ai 'a e ngaahi pisinisi mo e kakai taautaha 'i Tongatapu' ni pe a pehē ki he ngaahi 'otu motu', 'oku nau fakahoko 'a e fakafetongi pa'anga muli' ki he kakai 'o e fonua' ka 'oku 'ikai ke nau ma'u ha laiseni ngofua ke nau fakahoko 'a e fakafetongi pa'anga muli. Kataki 'o fakatokanga'i ange ko kinautolu pe kuo fakamafai'i (authorised persons) ke nau fakahoko 'a e fakafetongi pa'anga muli' ki he kakai 'o e fonua', 'a kinautolu kuo 'osi ma'u 'enau laiseni mei he Pangikē Pule', 'o fakatatau ki he kupu 13(1) 'o e Lao ki hono Pule'i 'o e Fetongi Pa'anga Muli 2018'. Ko ia ai, 'o kapau 'oku fakahoko 'e ha taha 'a e fakafetongi pa'anga muli' 'o 'ikai ha'ane laiseni, 'oku ne fakahoko 'a e hia pea 'e ala mo'ua 'i ha'ane halaia ki ha mo'ua pa'anga 'oku 'ikai lahi hake 'i he \$10,000 pē ki he ngāue popula ki ha vaha'a taimi 'ikai laka hake 'i he ta'u 'e tolu pē fakatou'osi 'o fakatatau ki he kupu 13(3) 'o e Lao ki hono Pule'i 'o e Fetongi Pa'anga Muli 2018'.

'Oku 'oatu ai 'a e fakatokanga'ni ki he kakai 'o e fonua' ke **TA'OFI** 'a hono fakahoko 'o ha fakafetongi pa'anga muli mo ha taha pē pisinisi ta'efakalao. 'Oku mau tapou atu ki he kakai 'o e fonua' ke mou fetu'utaki mai ki he Pangikē Pule' fekau'aki mo ha taha pē ha kautaha 'oku ne fakahoko ha fakafetongi pa'anga muli ta'efakalao. 'Oku malava ke tala ha tokotaha kuo 'osi ma'u laiseni' 'aki 'a e fakahā 'ene laiseni' 'i he feitu'u 'oku fakahoko ai 'ene pisinisi'. Ko kinautolu kotoa pē 'oku nau fakahoko 'a e fakafetongi pa'anga muli ta'efakalao'ni, 'oku fiema'u leva ke ta'ofi he vave taha' pea fakahū 'a e tohi kole laiseni ki he Pangikē Pule'.
