## **PRESS RELEASE**

### **National Reserve Bank of Tonga: Statement on Monetary Policy**

The National Reserve Bank of Tonga (NRBT) today releases its Monetary Policy Statement for September 2008. The Monetary Policy Statement is released every six months and is aimed at highlighting the issues affecting monetary policy settings and the role of monetary policy in achieving the Reserve Bank's objectives. The Monetary Policy Statement aims to inform the public of the role of the Reserve Bank in achieving macroeconomic stability and to promote informed debate on economic issues. The six-monthly Monetary Policy Statement is also part of the Reserve Bank's effort to be more accountable and more transparent in carrying out its functions as stipulated by the NRBT (Amendment) Act, 2007.

"The September Monetary Policy Statement is released at a time of heightened uncertainty in global financial markets," says NRBT Governor Siosi Mafi. "Financial systems around the world are under pressure with some financial institutions failing and some surviving only due to massive government-funded bailouts. As such monetary policy around the world is taking a bit of a back seat as central banks focus on the function of maintaining financial stability," she added.

While the world economy struggles, the Tongan economy is estimated to have embarked on a modest path to recovery. Growth is being spurred by new investment financed by high lending growth. Along with renewed economic growth the Tongan economy is experiencing rising imports, rising inflation, rising non-performing loans, falling foreign reserves, and tighter domestic liquidity to the end of July.

While foreign reserves have been falling up until July, large expected inflows have reversed this declining trend. The NRBT is pleased to see the increase of foreign reserves, but also is mindful that extra funds in the banking system may see lending growth accelerate.

“A reacceleration of credit growth will put pressure on domestic resources, potentially leading to more inflation, higher imports and lower foreign reserves,” says Governor Mafi.

“Overall, the outlook for Tonga is sound,” Governor Mafi says. “Despite the risk posed by high rates of lending, foreign reserves look set to remain comfortably above three months of imports for the foreseeable future. Also, inflation is expected to moderate as the price of oil, a significant import, has fallen dramatically in recent months. The threat to these comes from the pace of lending growth, where the Reserve Bank must weigh up the benefits of investment and economic growth against lower reserves, higher inflation and payment system efficiency.”

The Reserve Bank has cautioned the domestic banks to manage their lending prudently against the quality of their portfolio and their future payments obligations to ensure that adequate liquidity is maintained in the banking system at all times.

“The NRBT will be closely monitoring the growth in lending against foreign payments obligations by the financial system and will commence issuing NRBT notes if necessary to ensure financial stability and maintenance of adequate foreign reserves,” announced Governor Mafi.

Monetary Policy Statements will be published in English and Tongan on the Reserve Bank’s website, and distributed to interested parties and stakeholders. Copies are also available from the Reserve Bank upon request.

Ko e fakamatala ki he fokotu'utu'u ngaue fakapa'anga fakamahina ono ko 'eni, ko e konga pe ia 'a e feinga 'a e Pangike Pule ke taluii mo ha mahino ange 'a e fakahoko hono ngaahi fatongia 'a ia 'oku fakaha 'I he Lao Fakaangaanga 'a e Pangike Pule Fakafonua 'a Tonga, 2007.

'Oku pehe 'e he Kovana 'a e Pangike Pule Fakafonua 'a Tonga, Siosi Mafi ko e fakamatala ki he fokotu'utu'u ngaue fakapa'anga 'o Sepitema 'oku tukuange atu 'I he taimi 'oku matu'aki veiveiu'a e maketi fakapa'anga fakamamani lahi. 'Oku faingata'a'ia 'a e tu'unga fakapa'anga 'I mamani, 'a ia 'oku to lalo ai 'a e ngaahi kautaha fakapa'anga 'e ni'ihi, pea ko e ni'ihi 'oku nau kei faingamalie pe 'I he tokoni fakapa'anga lahi 'a e pule'anga. Ko ia ai, 'oku taafataha 'a e tokanga 'a e ngaahi Pangike Pule 'o e ngaahi fonua 'o mamani ki honau fatongia ke tauhi 'a e ma'uma'uluta mo e falala'anga 'a e tu'unga fakapa'anga honau ngaahi fonua.

Lolotonga 'a e faingata'a'ia 'a e tu'unga faka'ekonomika fakamamanilahi, 'oku fakafuofua ke fakalakalaka ai pe 'a e tu'unga faka'ekonomika 'a Tonga. Ko e tupu faka'ekonomika ko 'eni 'oku makatu'unga ia 'I he ngaahi ngaue fo'ou 'a ia 'oku fakapa'anga mei he tupu lahi 'a e ngaahi noo. Na'e pehe 'e he Kovana, "ko hono fakakatoa, 'oku 'I he tu'unga lelei 'a e fakafuofua ki he kaha'u 'o e tu'unga fak'ekonomika 'o Tonga.
